2) HAZARDS IDENTIFICATION

Based on available information SIMSHIELD - PROTECTIVE TOP COAT is classified as non-hazardous according to criteria of NOHSC.

3) COMPOSITION/INFORMATION ON INGREDIENTS

Product Description: UV and heat reflective acrylic coating applied by brush, roller or spray.

4) FIRST AID MEASURES

Inhalation: Remove victim from area of exposure. Remove contaminated clothing. Allow patient to be as comfortable as possible and

Storage Advice: Keep out of reach of children. Store in a cool dry place out of direct sunlight. Keep containers closed when not in use –

check regularly for leaks and $\mbox{\rm mix}$ well before next use.
